

#### Cuyahoga Falls City School District Parent/Guardian and Family Engagement Policy

In support of strengthening student academic achievement, Silver Lake Elementary School receives Title I, Part A funds and must jointly develop with, agree upon with, and distribute to parents, guardians, and family members of participating children a written Parent/Guardian and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). Goal Statement and Commitment: At Silver Lake Elementary we believe that ALL STUDENTS WILL ACHIEVE AT HIGH LEVELS. It is our goal that every child should have the opportunity to attain his/her full potential.

The Instructional Focus will include the following:

- We will teach the core academic standards to all students, in every classroom, every day, and in ways that meet each student's learning style.
- We will set high expectations for everyone students, educators, parents, community and support them in meeting high standards of behavior and outcomes.
- We will build strong relationships with families and communities because our schools can't do it alone.
- We will base all decisions on data
- Limit number of students in each session to five or less
- Provide flexible grouping of students; groups will be adjusted based on students needs
- Utilize UFLI and Leveled Literacy Interventions
- Use Acadience subtest, reading composite scores, UFLI assessments, observations, and conferring with students to drive instruction
- Provide small group interventions based on focused skill needs

Silver Lake Elementary agrees to implement the following requirements as outlined by Section 1116:

- Involve Parents/Guardians, in an organized, ongoing and timely way, in the planning, review and improvement of programs under Title I, Part A, including the planning, review and improvement of the school Parent/Guardian and family engagement policy and the joint development of the schoolwide program plan.

## • Jointly Developed

## Communications

Silver Lake Elementary will take the following actions to provide Parent/Guardians of participating children the following:

- Timely information about the Title I programs;
- Flexible number of meetings, such as meetings in the morning or evening, and may provide Title I funds, transportation, childcare or home visits, as such services relate to Parent/Guardian and family engagement; and
- Information related to the school and Parent/Guardian programs, meetings and 0 other activities is sent to the Parent/Guardians of participating children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the Parent/Guardians can understand.
  - Copies of the Parent/Guardian and family engagement policy will be distributed at the annual meeting and at Parent/Guardian meetings. It will also be located on the Silver Lake Elementary webpage.
  - School and Parent/Guardian programs will be communicated via Parent/Guardian newsletters. via school social media. Parent/GuardianSquare, and through occasional one-call notifications
  - Families will receive periodic progress reports for their child via email
  - Parent/Guardians will be provided access to have individual meetings with Title I staff during Parent/Guardian teacher conferences
  - Communication will be communicated in a language that is understood by the Parent/Guardians, when necessary.

## • Coordination of Services

# • Building Capacity of School Staff

Silver Lake Elementary will provide training to educate teachers, specialized instructional support personnel, principals and other school leaders, and other leaders, and other staff, with the assistance of Parents/Guardians, the value and utility of contributions of Parents/Guardians and in how to reach out to, communicate with and work with Parents/Guardians as equal partners, implement and coordinate Parent/Guardian programs, and build ties between Parent/Guardians and the school by:

- Two Parent/Guardian teacher conferences will be held annually to enable Parent/Guardians to share information with the student's team of educators and get information regarding their child's progress
- Silver Lake Elementary PTO will work collaboratively with building administration and staff to determine the best way to communicate with families and assist with the coordination of Parent/Guardian programs.
